Purpose

Full compliance with the Code, plus an understanding of the concepts behind it, will ensure the safety of maritime transport (and of course the environment), and ensure that Australian and international laws are not broken.

The course is designed to provide comprehensive training in the theory and practical aspects of shipping dangerous goods by sea. It examines the IMDG Code and provides you with a systematic approach to packaging and documenting a hazardous shipment for sea transport. There are follow-up exercises to reinforce the knowledge acquired.

It's also ideal for freight forwarders and consolidators involved with sea freight, and anyone needing a comprehensive understanding of the processed of shipping dangerous goods by sea.
